#### <u>AUTHORIZATION TO DEVELOP PROGRAMS UNDER THE HOMEOWNERS ASSISTANCE</u> <u>FUND – ITEM 2A.</u>

Aimee Manocchio Nason moved and Stanley Weeks seconded. 1. Approval by the New Jersey Housing and Mortgage Finance Agency (the "Agency") of the proposed programmatic guidelines in substantially the form attached hereto, for the Emergency Rescue Mortgage Assistance ("ERMA") Phase I Pilot Program, a mortgage reinstatement program utilizing funds allocated from the United States Department of the

Treasury's ("U.S. Treasury") Homeowner Assistance Fund ("HAF"). 2. Approval by the Agency of the proposed programmatic guidelines in substantially the form attached hereto, for the HAF Housing Counseling Program, an outreach and counseling program utilizing HAF funds. 3. Approval to utilize up to \$11 million of the initial 10% HAF allocation to launch a Phase I Pilot program (the "Pilot") that includes \$10 million for the ERMA Phase I Pilot Program and \$1 million for the HAF Housing Counseling Program.

Approval to allow the Executive Director in consultation with the Attorney General's Office to take any and all actions for the purpose of developing and implementing the Pilot including revising the program guidelines or creating any needed policies as a result of additional guidance or terms provided by U.S. Treasury, standards or policies set forth by the State, and public comments received; provided that the Executive Director will report to the Agency any revisions to the program guidelines for the Pilot or any policies created for the Pilot as a result of guidance from U.S. Treasury, the State or public comments received at the U.S. Treasury-required public listening session.


